Rein in Sarcoma (RIS) was started in 2001 by Karen Wyckoff, a 25-year-old Synovial Sarcoma Patient. As she fought a rare cancer, she found that there were three things that she thought needed doing to increase the quality of life and the odds of survival for all sarcoma patients. As she started the organization, she stated the mission: "We are dedicated to educating the public and medical community about sarcoma, supporting sarcoma patients and their loved ones, and funding research directed toward developing new treatments and finding a cure for sarcoma cancers." * Finding Cures for Sarcoma Cancers: o RIS has worked with the doctors and the medical school at the University of Minnesota. RIS has funded over 2M in innovative, collaborative and high impact research. o Seventy-seven sarcoma research grants have been funded. RIS has served patients at Mayo Clinic and Children's Hospitals and Clinics of Minnesota. These three institutions are serving the majority of sarcoma patients in Minnesota. * Education: o RIS worked to get sarcoma into the curriculum at all three medical schools in Minnesota. For the last twelve years, RIS has funded RIS Jan Maudlin Sarcoma Scholars at the University of Minnesota Medical School and Mayo Medical School. They plan educational programs for their peers and the public. Six RIS Sarcoma scholars have been selected for
